Basic Information Rules and State Requirements

1. **Enrollment: Enrollment is limited.** Our hope is to have enough room for all children wishing to participate in our *Mount Pleasant After-School* program, however we can't always accommodate everyone. After receiving your completed forms, the Site Supervisor will call to let you know if your child will be participating in the program and the date that they may begin. Each school holds registration at the principal's discretion. _____

2. **Attendance:** Students must attend program 5 days a week/3 hours a day and until 6:00pm. Regular attendance is mandatory. Children who have 3 unexcused absences will be asked to leave the program. Students may attend the program only on days they attend school. Children are expected to stay for the entire duration of the after school program each day. If a student is absent, written or verbal notification must be submitted to the site supervisor the next program day. Students may be asked to return home until verification of absence is turned in. Students participating in out of school activities will be asked to leave program for duration of the activity. _____

3. **Student Pick-Up:** Children participating in the *Mount Pleasant After-School* program must be signed out by you or someone designated on the registration form (designated person must be 16 years of age and on registration forms). Your child must be picked up promptly at the end of the program. If your child has not been picked up by the end of the program, site staff will try to contact you and/or those individuals designated as emergency contacts. **Three late pick-ups will result in your child being dropped from the *Mount Pleasant After-School* program.** In the case of not being able to contact an adult, CPS (child protective services) may be called. _____

4. **Discipline:** Participation in the *Mount Pleasant After-School* program is a privilege. A child must follow the rules of the program. *Mount Pleasant After-School* supports all core day school rules. Disruptive or disrespectful behavior towards other students or staff is cause for dismissal. We encourage you to discuss concerns about your child's behavior with the Site Supervisor. _____
